Lately I have run across a couple of tidbits of info that you might find interesting. The first is "Active Captain" if you are not already familiar with it, that Frank Barron, AP turned me onto. Whether you are preparing for a long cruise or just going out in our local waters "Active Captain" provides information pertaining to safety and convenience. You may get all the information at: https://activecaptain.com/. Just register and you can immediately start getting pertinent info.

The second tidbit is the dangers of following the magenta line and commercial predetermined routes. If you have completed P or AP, read just about any navigation book, or have read your chartplotter's manual then you know you never depend on just one source of navigational information. A case in point, is a couple I just recently read about who were following a pre-plotted route on their chartplotter just east of the Great Exuma Island and lost their 40' catamaran to the rocks. The article described the couple as experience boaters who had logged over 10,000 miles on this boat alone. If they had just checked the paper charts or their computer's electronic charts their mishap probably could have been avoided. Bottom line, use several charting sources and make sure you keep your charts up-to-date.

If you are interested in the America's Cup I have included the TV schedule below. I suppose I am a more traditional mono hull type sailor myself, but when the big cats get a little wind they can run over 50 mph which has got to be exciting if not darn right scary.

A different way of thinking about boating safety - Part 2 ©

Could you break the "Error Chain"?

We all think we're pretty savvy boaters, right? ...Been boating for years...no problem. When I hear that, I flinch. I hear complacency setting in, and it's a dangerous phenomenon.

Last time we talked about the Error Chain and what the concept is. This time let's talk about identifying errors, as subtle as they are sometimes. The below narrative is for discussion and education only – no judgment implied. Think of it this way – if you were a guest or crew, would you speak up? As captain, would you say no to friends? See if you would have "balked" at any of the facts or events leading up to fatal disaster.

About a year ago, a 34' Sliverton cabin cruiser was cruising the Oyster Bay waters off Long Island, NY on an evening cruise to watch fireworks. The vessel had a fly bridge for crew and passengers, a foredeck, aft cockpit and a modest cabin. On this cruise, there were 17 adults and 10 children aboard.


About 10pm the vessel capsized, throwing all but three children away from the vessel. The three children were trapped inside and drowned. They did not have life jackets on, as inside a cabin of this size, a child is not required to do so. If trapped, it's not clear if wearing one would have helped.

For education sake, let's imagine and expand some of the subtle threats of this voyage. Darkness, congestion of proximate vessels – thus increased wake, too many people aboard, everyone desiring to be on an elevated vantage point for better viewing (think stability) could have contributed significantly. Darkness brings on its own set of threats (confusion & situational awareness), congestion & wake can make seamanship more challenging, and pressure from friends (direct or implied) can detract from sound judgment. Could the elimination of any one of these threats have changed the outcome – maybe, maybe not? In my opinion, it was the collision of all these threats that resulted in the tragedy.

When presented as above, of course "red flags" go up. But what I want to keep on the forefront of your thinking is some of these items (and others not mentioned) are presented to each voyage we embark on. But here's the main point – can you identify a "threat" and manage it?! Would you speak up?

By digging this deep into the "whys" of an incident, I by no means want to lead you into ignoring the time tested USCG and US Power Squadron safety principals – always review the seaworthiness of the vessel & are the seas too much for this vessel. Tell friends where and when you're going. Are you embarking on a voyage above your level of competence? Pack safely – passenger limits, life jackets, flairs, radios....you get it. But ya know what? There's always a US Power Squadron Vessel Examiner willing to make a personal

inspection of your vessel and they're ready to discuss any safety questions that you have. Go on...call me!





Till then, be aware...
